The Deputy Mayor added a short trip to Kuala Lumpur as it is now an increasingly important investor into London. The Deputy Mayor undertook a programme of meetings alongside the Acting High Commissioner with the Deputy Mayor of Kuala Lumpur, as well as high-level corporate meetings with major capital investors to support their future investment plans into London. He also met with leading Malaysian venture funds who are actively pursuing investment into London technology firms and supporting Malaysian entrepreneurs with their European expansion plans. He also met with the Minister of Digital in Malaysia and his team leading their plans to bring a strong Malaysian delegation to London Tech Week 2025.

London & Partners international trade missions - background and objectives

International trade visits constitute a fundamental component of the Grow London Global initiative, previously known as the Mayor's International Business Programme. In the framework of this programme, the team facilitates trade missions for groups of 10 to 15 businesses to strategic markets, allowing these companies to establish connections in their target markets. Throughout these visits, participating companies engage in a series of activities including meetings with corporates, venture capital firms, ecosystem gatherings and interactions with governmental bodies and more.

The trade missions have often seen the inclusion of the Deputy Mayor for Business, whose presence serves to amplify the visibility of the businesses and to facilitate access to various opportunities. Furthermore, in order to optimise the Deputy Mayor's involvement, we orchestrate meetings with a diverse array of foreign enterprises interested in investing in London.

The value or return on investment (ROI) of his engagement is truly outstanding. A compelling illustration of this can be seen in the case of our visit to Dubai and Abu Dhabi, where one of the participating businesses, Wealth Dynamix, not only successfully expanded their operations in Dubai but also generated a substantial Gross Value Add (GVA) of £9m.
